# STANDING UP DATA GOVERNANCE FOR CRM

## SITUATION

A Fortune 1000 company's customer relationship management (CRM) team used Salesforce to host potential, former, and current client data that connected to other Finance and ERP systems. Practitioners input redundant, inaccurate, and non-standard data, resulting in unreliable data that could not be used for accurate reporting. The inaccurate and incomplete data resulted in employees working outside Salesforce that led to missed opportunities, negatively impacting revenue opportunities. The CRM team wasted thousands of hours communicating back and forth with system administrators from other Finance and ERP systems to rectify data quality issues.
