Corporate Integrity Agreement

FTI Consulting served as Independent Review Organization ("IRO") for a Urine Drug Testing ("UDT") Lab under their Corporate Integrity Agreement ("CIA") with the OIG. As the IRO, FTI Consulting conducted an annual review of the lab's systems, processes, policies, and procedures related to Focus Arrangements for the five-year term of the CIA.



Board Compliance Expert

FTI Consulting serves as the Board Compliance Expert ("BCE") for a Drug Testing Lab under their CIA. In our function as BCE, we evaluated the overall effectiveness of the organization's compliance program relative to prevailing OIG and CMS guidance and regulatory requirements and common industry practices.





Billing and Coding Investigation

FTI Consulting assisted a diagnostic laboratory company that was the subject of an investigation into claims submitted to Medicare for diagnostic tests using a product that was alleged not to be effective. This involved analyzing billing data and sales data to develop models of test usage and Medicare billing. We worked with counsel to analyze and rebut damage claims and prepare alternative damage models.



Diagnostic Testing Pricing and Contracting Practices

FTI Consulting assisted a laboratory company that was the subject of both Medicare and Medicaid investigations into diagnostic testing pricing and contracting practices. FTI Consulting utilized the company's data and data from outside sources to analyze fee schedules and pricing and billing from various physician groups, hospital and payer populations as well as cost information related to a number of testing centers. We also analyzed trends of Medicare, Medicaid and private payer test requisitions. This work culminated in a detailed response to the government's restitution demands and the development of alternative approaches to framing potential damages.



Evaluating Business Projections

FTI Consulting assisted a committee of lenders in evaluating business projections related to UDT and other laboratory testing revenue for an entity that was the subject of a DOJ and CMS investigation into billing practices. The review also involved assessing the relevant billing guidelines for Medicare, Medicaid and Commercial payers along with the company's billing practices.
